Exhibit 10**Description:** EXPLANATION OF INVOLUNTARY TRANSFER

THIS APPLICATION IS SUBMITTED DUE TO THE DEATH OF FLORENCE H. WRAY (AKA FLORENCE HENDRICK WRAY), UPON WHICH, COUPLED WITH THE DEATH EARLIER IN 2008 OF GEORGE D. WRAY, MORE THAN HALF OF THE VOTING INTERESTS APPROVED BY THE COMMISSION IN THIS LICENSEES LAST 'LONG FORM' TRANSFER APPLICATION (FCC FILE NO. BTCCT-19920608KF) HAVE NOW CHANGED HANDS.

AS WAS TRUE AT THE TIME THE COMMISSION APPROVED THE LAST LONG FORM IN 1992, NO SINGLE INDIVIDUAL OR ENTITY HOLDS EITHER NEGATIVE OR POSITIVE CONTROL IN THIS LICENSEE.

AT HER DEATH, FLORENCE H. WRAY HAD VOTING RIGHTS TO 41.91% OF KTBS, INC. STOCK. AT HIS EARLIER DEATH, GEORGE D. WRAY HAD VOTING RIGHTS TO 13.19% OF KTBS, INC. STOCK. FLORENCE H. WRAY AND GEORGE D. WRAY WERE EACH APPROVED INDIVIDUALLY AS OWNERS OF KTBS, INC. IN THE FCCS GRANT OF BTCCT-19920608KF.

AT HER DEATH, FLORENCE H. WRAY HAD FULL OWNERSHIP AND VOTING RIGHTS IN 18.87% OF THE KTBS, INC. STOCK, WHICH IS NOW IN HER ESTATE. THE CO-EXECUTORS OF FLORENCE H. WRAYS ESTATE, LOIS WRAY ROWE AND EDWIN N. WRAY, JR., WERE PASSED UPON AND APPROVED BY THE FCC AS OWNERS OF KTBS, INC. IN ITS GRANT OF BTCCT-19920608KF.

AT HER DEATH FLORENCE D. WRAY ALSO VOTED 23.04% OF KTBS, INC. STOCK AS 'USUFRUCTARY.' THAT STOCK IS NOW OWNED BY EDWIN N. WRAY, JR. (11.52%) AND LOIS WRAY ROWE (11.52%), THE 'NAKED OWNERS' OF THE STOCK DURING THE PERIOD OF THE USUFRUCT.

BY OPERATION OF LAW, THOSE INTERESTS PREVIOUSLY NOTED AND BENEFICIALLY OWNED BY FLORENCE H. WRAY, IN HER ROLES AS USUFRUCTARY, AUTOMATICALLY PASSED UPON HER DEATH TO THE NAKED OWNERS WHOSE RIGHTS MRS. WRAY OTHERWISE ENJOYED FOR THE DURATION OF HER LIFE.

UNDER LOUISIANA'S CIVIL CODE, RIGHTS SUBJECT TO A USUFRUCT CHANGE HANDS INVOLUNTARILY WITHOUT SUCH LEGAL INTERVENTIONS AS ESTATE OR PROBATE PROCESSES. INSOFAR AS SUCH CHANGES ARE AUTOMATIC UNDER LOUISIANA LAW, THE PASSING OF THESE USUFRUCT INTERESTS ARE SHOW HEREIN THROUGH THE INCREASE IN EQUITY AND VOTES HELD BY THE TWO NAKED OWNERS, LOIS WRAY ROWE AND EDWIN N.
